For the removal of doubts it is hereby declared that all the objects of the trust will be carried out without any motive for profit.








2. The Chairman of the Board of the Trustees shall be in General charge of the administration, employment, removal of employees etc. A secretary may be appointed by the Board of Trustees for the day-to-day administration of the Trust under the supervision and control of the Chairman and Trustees.






